- 1. <u>Call to Order/Roll Call/Agenda Review</u> Meeting convened at 12:31 PM.
- Motion to Approve October 15, 2024 Meeting Minutes Motion to approve minutes. Motion/Second: Taylor/Sones Motion passed unanimously.
- 3. Public Comment: None
- 4. New Business/Action Items:
  - 4.1. Presentation: *Health Information Exchange, a Primer for Seniors* Chavez provided an overview of the purpose and services of the Serving Communities Health Information Organization (SCHIO), an electronic health information exchange that allows health care providers and patients to appropriately access and securely share a patient's vital health information electronically. The system prioritizes accuracy, patient focus, and coordinated healthcare. Commissioners discussed access, security, data collection and sharing consent.

Rivas arrived.

4.2. Consider Advocacy Opportunities for CSL Legislative Priorities Commission considered the top CSL legislative priorities and discussed advocacy opportunities.

Motion to establish an ad hoc Legislative Subcommittee authorized to review, prioritize, and recommend support for the top 3-5 proposed bills. Motion/Second: Mark/Sones

Motion passed unanimously

Doty appointed Johannessen, Rodriguez, Sones, Doty and Taylor to the Ad Hoc Legislative Subcommittee

4.3. Consider Participation Opportunities in Future Senior Resource Fairs Commission discussed opportunities to facilitate, support and participate in senior resource fairs throughout the County. Ideally, the senior centers would lead the efforts, and the Commission would support their efforts by liaising with the planning committees, promoting attendance and participating in their events.

### Motion to form an Ad Hoc Senior Resource Fair Outreach and Planning Subcommittee authorized to contact senior centers to gauge interest, implement planning and report back to the Commission in February.

Motion/Second: Taylor/Rivas

Motion passed unanimously.

#### Doty appointed Taylor, Rivas, Childers, Doty, and Sones

4.4. Commission Strategic Action Planning for 2025

Commission discussed potential priorities for Commission in action in 2025. The Solutions Summit identified the following priorities and established the following work groups: *Reimagining Health Care, Affording Aging, Housing for all Stages and Ages, Inclusion and Equity, Not Isolation, and Caregiving that Works*. Topic will be revisited in February 2025.

#### 4. District Reports

5.1. District 1:

Doty shared information on a balance workshop with residents in her community. Commission discussed the siloed resource sources. Taylor did a reading of an anthology featuring writings of women over 80 at the mid-county senior center.

5.2. District 2

Rivas reported on the Watsonville Senior Center Senior Action Committee's progress as they develop an Age Well Action Plan for Watsonville City. Johannessen is serving on the AAA's review committee tasked with developing the next four-year RFP. Publication is scheduled for early 2025 and Johannessen will update the Commission. Commission discussed the Live Oak Senior Center's status in the absence of funding from a bond that did not pass.

5.3. District 3:

Sones reported on CORE funding for Elderday, though Meals on Wheels got carve-out funding. The concern is that safety nets for seniors are not being reliably considered in the current CORE funding process. Rodriguez confirmed her attendance at Solutions summit meetings.

#### The California Senior Legislature Announces Top Legislative Priorities for 2025

(*Sacramento, CA*) The California Senior Legislature (CSL) adjourned its 44th Annual Legislative Session and announced the Top State Legislative Proposals this week. Members will advocate diligently during the 2025 legislative session to have state lawmakers support these priorities.

#### The following were listed as the top ten State Legislative proposals:

#### SP-5: Medi-Cal Personal Needs

(Senior Senator Helen Lopez, El Centro, CA) MPA Goal # 2

This measure would increase the personal needs allowance from \$35 to \$50 per month and require that the amount be increased annually up to the amount of any cost-of-living adjustment implemented by the United States Social Security Administration.

#### SP-4: Ralph M Brown Act: Teleconferencing

(Senior Senator Stefan Lipson, El Cerrito, CA) MPA Goal # 3

This measure would authorize teleconferencing with respect to county based Advisory Councils, Committees, Commissions, and their attendant Work Groups, Committees, and Subcommittees established for aging and disabilities issues in the same manner as it was during the Covid-19 Pandemic.

#### SP-1: Documents: Execution by Patient in Skilled Nursing Facility

(Senior Senator Joyce Gandelman, Modesto, CA) MPA Goal # 3

This measure would require a document executed by a patient in a skilled nursing facility that limits or takes away a right of the patient, transfers real property owned by the patient, or transfers financial assets of the patient also be witnessed by an Ombudsperson.

#### AP-1: Out-of-State Physicians and Surgeons: Telehealth: License Exemption

(Senior Assembly Member Robin Clough, Santa Clarita, CA) MPA Goal # 4 This measure would authorize out-of-state telehealth for an eligible patient who, at a minimum, requires oncology services, without the requirement that the patient participate in a clinical.

#### **AP-10: Hospitals: Patient Discharge Summary**

(Senior Assembly Member Lavada Theus, Los Angeles, CA) MPA Goal # 2

This measure requires a hospital to standardize the Patient Discharge Summary, including specified information, in order to improve communication and provide continuity of medical care during the patient's transition to the home or another facility.

#### AP-2: Caregiving Grandparents: Support

(Senior Assembly Member Mark Cox, El Centro, CA) MPA Goal # 5

This measure requests that the California Department of Aging, Department of Justice, and State Department of Social Services conduct a study to examine the problems that grandparents who are primary caregivers for their grandchildren experience.

#### **AP-6: Health Facilities: Transfer of Patients: Requirements**

(Senior Assembly Member Deborah Nattress, Lorma Linda, CA) MPA Goal # 2

This measure requires a general acute care hospital to provide documentation, before physically transferring a patient, to a receiving health facility regarding a detailed care plan and needed medication list for the patient.

#### **AP-9: Confidential Marriage**

(Senior Assembly Member David Tetzlaff, Mission Viejo, CA) MPA Goal # 3

This measure repeals Confidential Marriage Statutes, but with a Grandfather Clause that maintains the confidentiality of Confidential Marriages that were performed before the effective date of the Legislation. Additionally, the measure would provide that these Confidential Marriages do not become public records, unless the parties involved voluntarily choose to make the marriages public records.

#### **AP-8: Senior Friendly Homes**

(Senior Assembly Member Ted Smith, South Pasadena, CA) MPA Goal # 1

This measure would recognize the role aging has on quality of life by defining "Senior Friendly Homes" and establishing criteria for use by seniors, family members, the Government, Social Agencies, and developers to evaluate and build an optimal place to live.

#### AP-11: Older Adults: Fall Prevention: Lighting

(Senior Assembly Member Richard White, Vacaville, CA) MPA Goal # 2

This measure (1) requires the adoption, development, and implementation of a comprehensive program to support and fund the installation of improved lighting in the homes of older adults, (2) requires the inclusion of specific lighting products as a type of injury prevention equipment that is covered under the program for injury prevention in the home environment, and (3) increases the maximum allowance for injury prevention equipment and other services under the program to \$1,000 per household.

The California Senior Legislature put forth one Federal Proposal for 2025.

#### AFP-1: Veterans: Cancer Biomarker Testing

(Senior Assembly Member Dorio, Santa Clarita, CA) MPA Goal # 2 This measure mandates the United States Department of Veterans Affairs to provide Veterans with Cancer Biomarker testing.

#### Chapter 2.78 SENIORS COMMISSION

Sections:

- 2.78.010 Established—Statutory authority.

2.78.050 Powers and duties.

#### 2.78.010 Established—Statutory authority.

The Seniors Commission is hereby established under the authority of Government Code Section <u>31000.1</u>, in compliance with SCCC <u>2.38.060</u>. [Ord. 3464 § 1, 1983; Ord. 2119, 1975; prior code § 3.25.010].

#### 2.78.020 Membership.

The Commission shall consist of 10 voting members, residents of the County, appointed by the Board of Supervisors. Each Supervisor shall nominate two persons, one of whom shall be over 60 years of age, who may reside within the Supervisor's district to serve on the Commission. In addition, the local representatives to the California Senior Legislature shall from time to time select one of the local representatives of that body to be a nonvoting member of the Commission. [Ord. 5278 § 21, 2018; Ord. 4303 § 1, 1994; Ord. 3464 § 1, 1983; Ord. 2119, 1975; prior code § 3.25.030].

#### 2.78.030 Term of office.

Each voting member shall serve for a term of four years, commencing on April 1st of the year in which the member's nominating Supervisor begins a full term. [Ord. 4303 § 2, 1994; Ord. 3464 § 1, 1983; Ord. 2119, 1975; prior code § 3.25.040].

#### 2.78.040 Organization and procedures.

(A) General Organization. The Commission shall comply in all respects with SCCC <u>2.38.110</u> through <u>2.38.250</u> unless otherwise provided herein.

(B) Staff Support. The County's Commissions Coordinator shall serve as administrative staff to the Commission and shall provide to the Board of Supervisors copies of all minutes, reports and recommendations created by the Commission. [Ord. 5278 § 21, 2018; Ord. 4325 § 3, 1994; Ord. 4303 § 3, 1994; Ord. 3464 § 1, 1983; Ord. 2119, 1975; prior code § 3.25.050].

#### 2.78.050 Powers and duties.

The Commission shall be responsible for performing the following duties:

(A) Advise the Board of Supervisors on all matters affecting senior citizens and make

recommendations to the County Administrative Officer and the Board of Supervisors on any senior citizens program proposal to be considered by the Board of Supervisors;

(B) Review the needs of senior citizens in the County, and develop a set of comprehensive goals and objectives for effectively meeting those needs;

(C) Monitor the various services made available to senior citizens by public and private agencies in this County to ensure efficient delivery of those services; and

(D) Communicate with Federal and State agencies and commissions serving senior citizens, and assist in the preparation, implementation and review of any regional plan or program designed to serve senior citizens. [Ord. 3464 § 1, 1983; Ord. 2119, 1975; prior code § 3.25.020].

ACTION 2D: Host or participate in local events of interest to seniors (e.g. District forums for seniors, family, & caregivers, fundraisers, fairs, etc.). Focus #3: (limited to four specific areas, but we can change any of the first three if we no longer want to monitor them) the fourth one meets one of our mandated duties.) Monitor and Assess Local Services, Programs and Agencies to Advocate for Effective Service Delivery to Seniors ACTION 3A: Monitor Safety Net Services on behalf of adults with cognitive impairment and those in advanced dementia conservatorship. ACTION 3B: Foster Age-in-Place solutions and community structures that support residents as they age, ensure affordable housing, and provide resources for unsheltered seniors. ACTION 3C: Monitor and promote accessible, affordable transportation for seniors ACTION 3D: Support County efforts to achieve AARP Age-Friendly designation and Master Plan for Aging implementation
